A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO DONATE AN INTEGRATED BARANGAY INFORMATION SYSTEM (IBIS) TO THE 142 BARANGAYS OF QUEZON CITY AND AUTHORIZING THE TRANSFER OF OWNERSHIP OF THE SAID SYSTEM TO THE BARANGAYS WITHOUT COST

WHEREAS, the Integrated Barangay Information System (IBIS) is a web-based and enterprise system with professional technical services to the Quezon City's 142 barangays to be centrally deployed to the City's Data Center for linkage to the City offices, the Quezon City Disaster Risk Reduction and Management Office (QCDRRMO) and the Quezon City Police District (QCPD) Data Center for their respective transactions pertaining to barangay matters;

WHEREAS, IBIS is featured to have uniformed standardized system modules namely: (1) Module 1 – Barangay Profile; (2) Module 2 – Barangay Resident Registry; (3) Module 3 – Barangay Peace and Order Registry; (4) Module 4 – Barangay Business Clearance Issuances; (5) Fingerprint Scanner; (6) 16MP Web Camera; (7) Digital Pentab for signatures; (8) Dual Sided ID Card Printer; (9) PVC Cards for ID; and (10) Computer Desktop;

WHEREAS, there is a desire to improve the Information System in the 142 barangays, to promote and develop plans and actions, to make basic services closer and reachable, to swiftly expedite business transactions, and to eradicate red tape in the service of the people;

WHEREAS, considering the importance of IBIS to the 142 barangays, the City General Services Department (CGSD) recommended the transfer of the IBIS to the 142 barangays through a Deed of Donation without cost.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to donate an Integrated Barangay Information System (IBIS) to the 142 Barangays of Quezon City and authorizing the transfer of ownership of the said system to the barangays without cost.

RESOLVED FURTHER, that the ownership of the IBIS be transferred to the 142 barangays through a Deed of Donation to be signed by the City Mayor, Honorable Ma. Josefina G. Belmonte and Mr. Ricardo B. Corpuz, City Government Department Head III, Barangay and Community Relations Department (BCRD) as the Donors and the 142 Punong Barangays, Quezon City as the Donees, and the Head of the City General Services Department (CGSD), as a witness.


