LUIS, BARANGAY NOVALICHES PROPER, DISTRICT V, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

WHEREAS, Bel-Fed Gaming Amusement Corporation, a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Mr. John Daniel M. Sy, with business address at No. 248 Shop'n Ride, Gen. Luis, Barangay Novaliches Proper, District V, Quezon City, Metro Manila, is applying for a Special Permit to operate an Electronic Bingo Games Establishment;

WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of the same business through Resolution No. SP-8389, S-2020;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its Special Permit pursuant to an existing City Ordinance;

WHEREAS, the aforementioned business activity will provide employment and additional revenue to the City Government;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a Special Permit to business activities of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, the Special Permit of Bel-Fed Gaming Amusement Corporation for the operation of an Electronic Bingo Games Establishment at No. 248 Shop'n Ride, Gen. Luis, Barangay Novaliches Proper, District V, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an Electronic Bingo (E-Bingo) Games Establishment granted herein shall be subject to the following conditions:

1. the holding of E-Bingo Games shall be in accordance with the rules and regulations promulgated by PAGCOR;
2. the operation of an E-Bingo Games Establishment shall not include playing of games not related to or other than E-Bingo;
3. the operation is enjoined to prohibit from playing the abovementioned games in their gaming site individuals below 21 years of age or students of any school, college or university;
4. Bel-Fed Gaming Amusement Corporation shall remit a license fee of 3% of the gross receipt of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution, in accordance with Section 25, Article III of Ordinance No. SP-2773, S-2018, as amended; and
5. this Resolution is non-assignable, non-transferrable and site-address specific.


