A RESOLUTION LIFTING THE STATE OF CALAMITY IN QUEZON CITY DUE TO TYPHOON CARINA AND THE ENHANCED SOUTHWEST MONSOON (HABAGAT), AS DECLARED THROUGH RESOLUTION NO. SP-9735, S-2024, PURSUANT TO QCDDRRMC RESOLUTION NO. 5, 2024 DATED SEPTEMBER 13, 2024

WHEREAS, on July 24, 2024, the Quezon City Council declared a State of Calamity in Quezon City through Resolution No. SP-9735, S-2024, due to the severe impact of Typhoon Carina and the enhanced Southwest Monsoon (Habagat);

WHEREAS, the declaration of a State of Calamity was necessary for the mobilization of resources, implementation of disaster response and recovery mechanisms, and provision of relief to the affected population;

WHEREAS, since the said declaration, the Quezon City Government, in coordination with national government agencies, has conducted comprehensive disaster response and recovery efforts, resulting in significant improvements in the affected areas;

WHEREAS, pursuant to the recently transmitted QCDDRRMC Resolution No. 5, 2024 dated September 13, 2024, the Quezon City Disaster Risk Reduction and Management Council (QCDDRRMC) recommended the lifting of the State of Calamity in Quezon City, noting that the conditions which led to the declaration of State of Calamity have been effectively addressed;

NOW, THEREFORE,




