WHEREAS, a graduate of the Philippine National Police Academy “Sinag-Tala” Class of 2012 and a seasoned strategist and tactical expert with 15 years of service, PMaj. Mark Ronan B. Balmaceda currently serves as the Deputy Force Commander of the Regional Mobile Force Battalion of the National Capital Region Police Office (NCRPO). His expertise in operations and intelligence has left an indelible mark on the Country’s enforcement landscape;

WHEREAS, PMaj. Balmaceda’s career was put into test during the siege of Marawi City in 2017; despite enduring significant losses, his unit persevered that their sacrifices are instrumental in turning the tide of battle;

WHEREAS, beyond the battlefield, PMaj. Balmaceda has been a driving force in reforming the Philippine National Police (PNP) from within, focusing on the critical stages of recruitment and training to elevate the integrity of their ranks;

WHEREAS, he spearheaded the development of Operational Plan “Pagsungko” in 2020 that marked the turning point, introducing unprecedented oversight through the deployment of PNP Integrity Monitoring and Enforcement Group (IMEG) to monitor recruitment activities nationwide, thereby leading to the apprehension of individuals involved in recruitment related misconduct and fostering a more equitable system for aspiring police officers;

WHEREAS, he also initiated Oplan “Bansay” (Bantay sa Pagsasanay) to safeguard the integrity of the PNP’s Basic Recruit Training Program. He also spearheaded the development of a security plan with proactive and reactive strategy that would shield the La Mesa Watershed from threats while preserving its ecological integrity;

WHEREAS, PMaj. Balmaceda’s career has been a relentless pursuit of justice, marked by critical assignments across the archipelago and has confronted the Country’s most dangerous threats head-on that led to the dismantling of notorious criminal networks, the capture of high value targets and the seizure of illicit contraband;

WHEREAS, PMaj. Balmaceda has distinguished himself as a leader adept at both strategic planning and tactical execution. His exceptional service has been recognized with over eighty (80) medals, awards and distinctions;


