WHEREAS, said 20 units of tents will be distributed to qualified beneficiaries from different barangays and organizations in the 4th District of Quezon City;

WHEREAS, the following are the specifications of the tents to be donated and distributed: steel frame, canvass, 11 feet x 11 feet;


WHEREAS, the donation of 20 units of tents aims to improve the delivery of administrative services in the 4th District of Quezon City;

WHEREAS, for the effective transfer of ownership to the recipients of the said 20 units of tents, the City, as Donor, shall assume all fees and cost of the donation.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Deed of Donation and Acceptance with various beneficiaries from the different barangays of the 4th District of Quezon City for the donation of 20 units of tents and authorizing the transfer of ownership thereof to all recipients without cost.
