WHEREAS, B-7 Amusement Corporation, a domestic corporation duly organized and existing under and by virtue of Philippine laws and now operated by Triple 8 Amusement and Development Corporation, is applying for the amendment of its Special Permit to operate an Electronic Bingo Games Establishment at 2/F Berkeley Square Commonwealth Avenue, Brgy. Matandang Balara, Quezon City;

WHEREAS, Quezon City Resolution No. SP-9692, S-2024 was adopted by the City Council last May 27, 2024 and the same is effective for 3 years or until 2027;

Matandang Balara, District III, Quezon City, subject to the Rules and Regulations promulgated by the Philippine Amusement Gaming Corporation (PAGCOR)" to amend the name of its operator.

RESOLVED FURTHER, that the Special Permit granted to B-7 Amusement Corporation through Quezon City Resolution No. SP-9692, S-2024 is now transferred to and owned by Triple 8 Amusement and Development Corporation.
