WHEREAS, the Country's artistic and historic wealth constitutes as cultural treasure of the Nation and shall be under the protection of the State;

WHEREAS, Republic Act No. 10066, also known as the "National Cultural Heritage Act of 2009," emphasizes the protection and preservation of the Country's cultural heritage, including tangible and intangible cultural properties;

WHEREAS, the Department of the Interior and Local Government (DILG) and the National Commission for Culture and the Arts (NCCA) issued Joint Memorandum Circular No. 2018-01, known as the "Local Inventory of Cultural Property as required under Republic Act No. 10066," enjoining the local government units to identify, establish, and maintain a local inventory of all cultural property within their jurisdiction;
