Abello Jr., is applying for the issuance of a Certificate of Exception for the Construction and Operation of As Built: 6-Storey Commercial Building with Mezzanine covering a total area of 1,306.65 square meters located at Lot 31, Block K-14, (No. 125) K-1st Street, Barangay Kamuning, District IV, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2016;

WHEREAS, the subject Construction and Operation has complied with the necessary requirements for the issuance of a Certificate of Exception as mandated by the Quezon City Comprehensive Zoning Ordinance of 2016.
