AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2, GENERAL FUND FOR FISCAL YEAR 2024, IN THE AMOUNT OF PHP34,509,098.00 TO COVER VARIOUS EXPENDITURES OF THE QUEZON CITY GOVERNMENT

WHEREAS, Quezon City Ordinance No. SP-3220, S-2023 approved the Quezon City Government's Annual Budget in the total amount of Php39,000,140,000.00 to fund the expenditures of the City Government for Fiscal Year 2024;

WHEREAS, there is a need to appropriate a Supplemental Budget in the amount of Php34,509,098.00 to fund various social services programs of the Quezon City Government;

WHEREAS, upon the recommendation of the Finance Committee, duly certified by the City Treasurer and the City Accountant, the said funds are actually available and there is a need to appropriate the amount of Php34,509,098.00, to fund various social services programs of the Quezon City Government, and for other purposes;

WHEREAS, it is imperative for the Sangguniang Panlungsod to approve Supplemental Budget No. 2, General Fund for Fiscal Year 2024 of Quezon City, in order to support and cover the expenses for the implementation of the various social services programs of the Quezon City Government.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. APPROPRIATION. – The amount of Php34,509,098.00 is hereby appropriated as an integral part of the General Fund Budget for Fiscal Year 2024 by way of Supplemental Budget No. 2 to finance the implementation of various social programs of the Quezon City Government.

SECTION 2. EXPENDITURES. – The appropriated amount of Php34,509,098.00, in accordance with the specific items of expenditures, is hereby broken down as follows:
