A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH BARANGAY DOÑA IMELDA, REPRESENTED BY ITS ACTING PUNONG BARANGAY ROLANDO S. MALAÑGEN, FOR THE REPURPOSING OF THE SECOND AND THIRD FLOORS OF THE BUILDING, WITH A TOTAL AREA OF 327.6 SQUARE METERS, OWNED BY THE QUEZON CITY GOVERNMENT LOCATED AT NO. 145 BAYANI STREET CORNER GUIRAYAN STREET, AREA 22, BARANGAY DOÑA IMELDA, DISTRICT IV, QUEZON CITY

WHEREAS, Barangay Doña Imelda is a local government unit located in the Fourth Legislative District of Quezon City;

WHEREAS, Barangay Doña Imelda is currently implementing a Healthcare Program for the benefit of its inhabitants which include the establishment of an accessible, affordable, and effective dialysis center;

WHEREAS, the said Barangay is occupying a Quezon City Government owned-building, with an area of 327.6 square meters, within its territorial jurisdiction, particularly located at No. 145 Bayani Street corner Guirayan Street;

WHEREAS, to maximize the use of the said building and in line with the Barangay's Healthcare Program, Barangay Doña Imelda is contemplating on utilizing the second and third floors thereof for the treatment of dialysis patients, hence the need to repurpose the portions of the said building;

WHEREAS, since the subject building is a City Government property, there is a need for the City Mayor and the Punong Barangay of Doña Imelda to execute a Memorandum of Agreement (MOA) for the repurposing of the second and third floors thereof;

WHEREAS, the Sanggunian of Barangay Doña Imelda, through its Resolution No. 023, S-2024, has authorized its Acting Punong Barangay Rolando S. Malañgen to enter into a MOA with the Quezon City Government for the repurposing of the second and third floors of the subject building;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with Barangay Doña Imelda, represented by its Acting Punong Barangay Rolando S. Malañgen, for the repurposing of the second and third floors of the building, with a total area of 327.6 square meters, owned by the Quezon City Government located at No. 145 Bayani Street corner Guirayan Street, Area 22, Barangay Doña Imelda, District IV, Quezon City.
