Belmonte, to acquire through negotiated sale and to execute a Deed of Absolute Sale for the purchase of parcel of land covered by Transfer Certificate of Title No. 004-2012008831, registered under the names of Joseph S. Doria married to Maria Victoria Del Rosario, et al., with an area of Five Hundred Twenty (520) square meters, more or less, and located at No. 64 Tatlong Hari Street, Barangay Sta. Monica, Novaliches, District V, Quezon City, intended for the development of a socialized housing project for the benefit of the Informal Settler Families (ISFs) in Quezon City.
