A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, FOR AND IN BEHALF OF THE LOCAL GOVERNMENT OF QUEZON CITY, TO EXECUTE CONTRACTS TO SELL/AGREEMENTS AND DEEDS OF ABSOLUTE SALE WITH THE QUALIFIED BENEFICIARIES OF THE CITY'S SOCIALIZED HOUSING PROGRAM UNDER THE DIRECT SALE PROGRAM FOR A PARCEL OF LAND COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 004-2020007933, REGISTERED UNDER THE NAME OF THE QUEZON CITY GOVERNMENT, WITH AN AREA OF 2,584 SQUARE METERS, MORE OR LESS, LOCATED IN BICOL COMPOUND, KINGSPOINT SUBDIVISION, BARANGAY BAGBAG, DISTRICT V, QUEZON CITY

WHEREAS, in the fulfillment of said mandate, the Quezon City Government had developed and implemented policies to provide affordable and adequate housing to all residents, especially Informal Settler Families (ISFs) living in danger areas;

WHEREAS, there is a need to introduce policies and programmatic interventions in order to achieve the City's goal of providing affordable and adequate housing for all of its residents;

WHEREAS, it is necessary to enter into Contracts to Sell/Agreements and Deeds of Absolute Sale and to sign other necessary documents pertaining to the City's Socialized Housing Program under the Direct Sale Program;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, for and in behalf of the Local Government of Quezon City, to execute Contracts to Sell/Agreements and Deeds of Absolute Sale with the qualified beneficiaries of the City's Socialized Housing Program under the Direct Sale Program for a parcel of land covered by Transfer Certificate of Title No. 004-2020007933, registered under the name of the Quezon City Government, with an area of 2,584 square meters, more or less, located in Bicol Compound, Kingspoint Subdivision, Barangay Bagbag, District V, Quezon City.
