WHEREAS, among her notable achievements is her historic ascent to Mount Apo, where she became the first blind female to reach its summit via the challenging Circumferential Trail of Sta. Cruz, Davao del Sur, from October 24 to 26, 2023, accompanied by her skilled guide, Sab Galon and her dedicated coach, Chezq;

WHEREAS, Ms. Torres also secured first place in a highly competitive high-altitude obstacle course racing event in Mount Pulag, Benguet last March 26, 2022;

WHEREAS, Ms. Torres is ambitiously planning to climb Mount Kinabalu in Malaysia, with the goal of becoming the first blind female to reach its summit;

WHEREAS, Ms. Torres is currently pursuing Bachelor of Science in Special Education at New Era University, balancing her academic commitments with her athletic endeavors;

WHEREAS, Ms. Torres' accomplishments highlight her exceptional resilience and outstanding skill. Ms. Torres aims not only to bring pride to the Philippines but also to advance inclusivity in the field of mountaineering.
