A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO GREAT MILESTONE CORP., AS REPRESENTED BY DAVID CHU TAN, FOR THE CONSTRUCTION AND OPERATION OF A PROPOSED FIVE (5)-STOREY COMMERCIAL BUILDING WITH UTILITY DECK LOCATED AT LOT 25, BLOCK 90, (NO. 190) MAGINHAWA STREET, BARANGAY SIKATUNA, DISTRICT IV, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER QUEZON CITY ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE OF 2016

WHEREAS, Great Milestone Corp., as represented by David Chu Tan, is applying for a Certificate of Exception for the construction and operation of their Project, a Proposed Five (5)-Storey Commercial Building with Utility Deck located at Lot 25, Block 90, (No. 190) Maginhawa Street, Barangay Sikatuna, District IV, Quezon City;

WHEREAS, pursuant to Section 55, Article VIII of Ordinance No. SP-2502, S-2016, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2016, exceptions and variances or deviations from the provisions of the said Zoning Ordinance may be allowed only upon authorization by the City Council, through a Resolution;

WHEREAS, the Proposed Project will not adversely affect public health, safety and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, the applicant has submitted all the necessary and mandatory requirements in support of the Proposed Project and has committed to comply with the provisions of existing laws, ordinances, and rules and regulations pertaining to public safety, environmental protection and vehicular traffic.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Certificate of Exception to Great Milestone Corp., as represented by David Chu Tan, for the construction and operation of a Proposed Five (5)-Storey Commercial Building with Utility Deck located at Lot 25, Block 90, (No. 190) Maginhawa Street, Barangay Sikatuna, District IV, *Ouezon City, allowing deviation from the restrictions provided under Quezon* City Ordinance No. SP-2502, S-2016, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2016.
