WHEREAS, it is necessary to enter into Contracts to Sell/Agreements and Deeds of Absolute Sale and to sign other necessary documents pertaining to the City's Socialized Housing Program under the Direct Sale Program;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, for and in behalf of the Local Government of Quezon City, to execute Contracts to Sell/Agreements and Deeds of Absolute Sale with the qualified beneficiaries of the City's Socialized Housing Program under the Direct Sale Program for parcels of land covered by Transfer Certificate of Title Nos. 004-2024004399, 004-2024004387, 004-2024004388, 004-2024004389, 004-2024004390, 004-2024004391, 004-2024004396, 004-2024004392, 004-2024004393, 004-2024004394, 004-2024004395, registered under the name of the Quezon City Government, with an aggregate area of Sixty Thousand Two Hundred Forty-Eight (60,248) square meters, more or less, and located in Sto. Niño and San Miguel Streets, Area A, Barangay Payatas, District II, Quezon City.
