A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO DONATE THE ONE HUNDRED FORTY-TWO (142) UNITS OF TOYOTA HI ACE COMMUTER VAN (TRANSPORT VEHICLES) TO ONE HUNDRED FORTY-TWO (142) BARANGAYS IN QUEZON CITY, AND TO TRANSFER THEIR OWNERSHIP TO THE RECIPIENT BARANGAYS WITHOUT COST

WHEREAS, Section 17(a) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them;

WHEREAS, the said provision of law further provides that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities;

WHEREAS, these transport vehicles will provide logistical support to the recipient barangays in attending to various activities within their respective territorial jurisdiction and the city and in other government functions;

WHEREAS, the aforementioned transport vehicles shall be used further by the recipient barangays to significantly enhance barangay operations and responsiveness to community needs and to be able to serve their constituents effectively;

WHEREAS, pursuant to Section 455(b)(1)(vi) of the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, a Deed of Donation shall be executed in favor of the recipient barangays, transferring the ownership of the said transport vehicles, thereby authorizing the recipient barangays to appropriate funds for the insurance, registration and maintenance of the subject transport vehicles.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to donate One Hundred Forty-Two (142) Units of Toyota Hi Ace Commuter Van (Transport Vehicles) to One Hundred Forty-Two (142) Barangays in Quezon City, and to transfer their ownership to the recipient barangays without cost.

RESOLVED FURTHER, that the ownership of the same be transferred to the recipient barangays, through a Deed of Donation, to be signed by the City Mayor, Honorable Ma. Josefina G. Belmonte, as Donor, and the Barangay Chairperson of the recipient barangay as Donee, with Honorable Jose Maria M. Rodriguez, President of the Liga ng mga Barangay, the City Government Department Heads of the City General Services Department (CGSD) and the Barangay and Community Relations Department (BCRD) as Witnesses.
