A RESOLUTION AMENDING THE INTERNAL RULES OF PROCEDURE OF THE $22^{\rm ND}$ QUEZON CITY COUNCIL, REVERTING THE SCHEDULE OF REGULAR SESSIONS TO MONDAYS ONLY

WHEREAS, Section 50 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates the adoption of the Internal Rules of Procedure of the Sangguniang Panlungsod during its first regular session following the election of its members;

WHEREAS, Quezon City Resolution No. SP-9641, S-2024 amended the Internal Rules of Procedure of the 22^{nd} Quezon City Council by setting regular sessions every Monday at 1:00 P.M. and every Wednesday at 11:00 A.M.;

WHEREAS, it has been observed that the holding of additional regular sessions every Wednesday has resulted in logistical and administrative challenges and there is a need to streamline the schedule to ensure optimal productivity and efficiency in legislative work;

WHEREAS, reverting to the previous schedule of holding regular sessions only on Mondays will allow for better preparation and deliberation on legislative measures while addressing concerns of time and resource management.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend, Quezon City Resolution No. SP-9641, S-2024 by revising Section 21 of the Internal Rules of Procedure of the 22^{nd} Quezon City Council to revert to the original schedule of holding regular sessions only on Mondays, which shall be read as follows:

"SECTION 21. REGULAR AND SPECIAL SESSIONS. – Following the election of the members of the Sangguniang Panlungsod, the regular sessions shall be held every **Monday at 1:00 P.M.** at the Carlos Albert Hall or such other place designated by the Sangguniang Panlungsod. In case the regular session day falls on a legal or special holiday, the session shall automatically be calendared on the next business day; provided, that in case of a fortuitous event causing the cancellation of a regular session day, the session shall automatically be calendared on the following Monday."
