ORDINANCE NO. SP- **3351**, S-2024

AN ORDINANCE IMPOSING ONE PESO (PHP1.00) INCREASE TO THE ADMISSION FEES IN ALL CINEMAS IN QUEZON CITY FOR A PERIOD OF THIRTY (30) SCREENING DAYS, THE PROCEEDS THEREOF ARE TO BE DONATED TO THE PHILIPPINE RED CROSS – QUEZON CITY CHAPTER, TO SUPPORT ITS NUMEROUS PROGRAMS AND ACTIVITIES

WHEREAS, the Philippine Red Cross – Quezon City Chapter has various programs and projects which need the continued assistance of the Quezon City Government in continuing their important projects in Quezon City;

WHEREAS, as a manifestation of support for the Red Cross of the Philippines – Quezon City Chapter, the City Government intends to increase the admission fees in all the cinemas within Quezon City by One Peso (Php1.00), thereby paving the way to the realization of the mission and vision of the Philippine Red Cross – Quezon City Chapter;

WHEREAS, the Philippine Red Cross – Quezon City Chapter has been involved not only in promoting health services but also in providing adequate training related to their duties and functions in providing health services to the people.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Admission fees in all cinemas/movie houses in Quezon City are hereby increased by One Peso (Php1.00) for thirty (30) screening days after the approval of this Ordinance.

SECTION 2. All concerned movie/cinema owners and operators are hereby authorized to transmit and turn over to the Quezon City Government all sum of money received or collected by virtue of this Ordinance to be donated to the Philippine Red Cross – Quezon City Chapter.

SECTION 3. The Philippine Red Cross – Quezon City Chapter shall make a proper accounting of the total amount they received, as well as the expenses incurred, with official receipts and pertinent documents to be submitted to the City Treasurer’s Office of Quezon City, subject to the usual government accounting and auditing rules. The City Treasurer, in this connection, is hereby directed to submit the corresponding report to the City Council within ten (10) days from receipt of the said pertinent documents.


SECTION 4. Upon approval, a copy of this Ordinance shall be furnished to the Philippine Red Cross – Quezon City Chapter, the City Treasurer’s Office, and to all owners/operators of cinema/movie houses doing business in Quezon City, for their information, guidance and proper action.

SECTION 5. EFFECTIVITY CLAUSE. – This Ordinance shall take effect immediately upon its approval.
