A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO KAIROS ELECTRICAL AND INDUSTRIAL SUPPLY INC. FOR THE PROPOSED AS-BUILT: THREE (3)-STOREY WAREHOUSE BUILDING (WHOLESALE OF ELECTRICAL AND INDUSTRIAL SUPPLIES) LOCATED AT LOT 1, BLOCK 47, SIMOUN STREET CORNER BLUMENTRITT EXTENSION, BARANGAY SAN ISIDRO LABRADOR, DISTRICT I, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER QUEZON CITY ORDINANCE NO. WHEREAS, *Kairos Electrical and Industrial Supply, Inc.* is applying for a Certificate of Exception for the proposed As-Built: Three (3)-Storey Warehouse Building (Wholesale of Electrical and Industrial Supplies) located at Lot 1, Block 47, Simoun Street corner Blumentritt Extension, Barangay San Isidro Labrador, District I, Quezon City;

WHEREAS, the Proposed Project will not adversely affect public health, safety and welfare and is in keeping with the general pattern of development in the community;


WHEREAS, the applicant has complied with all the necessary requirements prescribed by laws, ordinances or administrative issuances;


