WHEREAS, the Local Chief Executive may, upon the authority of the Sangguniang Panlungsod, secure financial grants or donation for such projects, facilities, programs, and services funded by the National Government, as provided in Section 23 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Honorable City Mayor is authorized to enter into contracts pursuant to Section 51 of the Administrative Code of 1987;

WHEREAS, the Quezon City Government fully supports the National Government, through the Department of Energy (DOE) programs, to promote modernization of the transport sector by providing an efficient, safe, ergonomic and environmentally-friendly alternative mode of transport through the "Market Transformation through the Introduction of Energy Efficient Vehicle (E-Trike) Project";

WHEREAS, two hundred ninety-nine (299) units of E-Trike were donated by the DOE to the Quezon City Government as part of its E-Trike Project;

WHEREAS, out of 299 units of E-Trike donated, 65 individuals successfully complied with the comprehensive deployment plan as mandatory requirements stated in the development plan submitted to the DOE and approved by the Asian Development Bank;
