WHEREAS, Mar Aviel Carredo is the youngest chess player to have garnered both gold and silver medals, along with several other awards, in numerous distinguished chess competitions held locally and internationally;

WHEREAS, aside from his impressive international achievements, Mar Aviel Carredo has excelled in chess tournaments held across various cities in the Philippines, including Marikina City, Marinduque City, Dapitan City, San Juan City, Tagaytay City, Dipolog City, Quezon City, Malolos City and Vigan City, where he has consistently earned awards and medals;

WHEREAS, he has represented the Philippines with honor in various prestigious international chess competitions, including the 21<sup>st</sup> ASEAN Age Group Chess Championship in Bangkok, Thailand (2023), the 2023 Merdeka Chess Festival in Kuala Lumpur, Malaysia, the 2024 Asian Youth Chess Championship in Almaty, Kazakhstan, and the 2024 22<sup>nd</sup> ASEAN Age Group Chess Championship in Vientiane, Laos;

WHEREAS, Mar Aviel Carredo's exceptional achievements bring immense pride to Quezon City and serve as a powerful inspiration to the youth of our community, motivating them to strive for excellence in their own pursuits.
