

AN ORDINANCE RECTIFYING THE FIVE (5) REGULAR PLANTILLA POSITIONS IN THE CASH DIVISION OF THE OFFICE OF THE CITY TREASURER, QUEZON CITY, PARTICULARLY THE POSITIONS OF CASH CLERK I (SG-4) TO CASH CLERK III (SG-8) AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.

WHEREAS, the position of Cash Clerk I in the Cash Division of the City Treasurer's Office involved tedious and complicated work in their daily transaction;

WHEREAS, the incumbent employees of the said division had appealed to rectify their positions and salary grades, the same being favorably endorsed by their Officer-In-Charge in a letter dated July 1, 1998;

WHEREAS, in accordance with Section 2 of R.A. 6758, otherwise known as "An Act Prescribing a Revised Compensation and Position Classification System in the Government", it is the declared policy of the State to provide equal pay for substantially equal work and to base differences in pay upon substantive requirements of the position by determining rate of pay;

WHEREAS, to avoid disparity in the rates of pay to City-paid employees which if left unsolved and unattended may result to demoralization to similarly situated Quezon City employees thus impairing the efficiency of public services there is a need to apply R.A. 6758;

WHEREAS, the City Council has the duty and power as provided for R.A. 7160, otherwise known as the Local Government Code of 1991, under Sec. 458 (a) (1) (viii) to determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures for the proper conduct of programs, projects and services of the City government.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:


