AN ORDINANCE AUTHORIZING ALL CINEMA OWNERS AND OPERATORS TO INCREASE THEATRE ADMISSION TICKET PRICES BY ONE PESO (P1.00) FROM MARCH 1, 2000 TO APRIL 30, 2000 FOR THE PURPOSE OF SUPPORTING THE CHARITABLE TWO HEARTS FOUNDATIONS PROJECT, "RESTORATION OF QUEZON CITY GENERAL HOSPITAL FACILITIES".

WHEREAS, Quezon City General Hospital is a 230-bed teaching and training hospital of the Quezon City government which aims to provide high quality health care to both in-patients and out-patients and primary health care to the residents of Quezon City, especially the indigents;

WHEREAS, there is a need to attend, not only to the physical health of the residents, but also to their spiritual needs;

WHEREAS, the Hospital's Chapel is in a dilapidated state and condition and needs to be renovated at the soonest possible time;

WHEREAS, there is no allocation in the local budget for Fiscal Year 2000 for the renovation thereof;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. All cinema owners and operators in Quezon City are hereby authorized to increase theater admission ticket prices by One Peso (P1.00) for the period March 1, 2000 to April 30, 2000.
