AN ORDINANCE AUTHORIZING THE CHATERS NEIGHBORHOOD ASSOCIATION, A CONFEDERATION OF CARMEL I, CARMEL II, HAYAVILLE, TERESA AND SAN MIGUEL-FULLON SUBDIVISIONS, TO CONSTRUCT, INSTALL, MAN AND MAINTAIN SECURITY GATES WITHIN THEIR RESPECTIVE AREAS OF THEIR ASSOCIATION IN BARANGAY BAHAY TORO, QUEZON CITY.

WHEREAS, the Local Government Code empowers local government units to enact measures necessary to promote the health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, the Barangay Council of Barangay Bahay Toro approved Resolution No. 142, S-1999, granting the CHATERS NEIGHBORHOOD ASSOCIATION, a confederation of CARMEL I, CARMEL II, HAYAVILLE, TERESA and SAN MIGUEL-FULLON SUBDIVISIONS, the authority to construct, install and man security gates within their respective areas of the association in Barangay Bahay Toro, Quezon City;

WHEREAS, the entrance to the security gates shall be closed only during critical hours from 11:00 P.M. to 5:00 A.M., thus allowing the free passage of vehicles during daytime in order to decongest traffic within the vicinity.

WHEREAS, the installation of security gates is necessary to ensure peace, order and comfort in the community and protect life and property of the residents therein.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED :

SECTION 1. The Chaters Neighborhood Association, a Confederation of Carmel I, Carmel II, Hayaville, Teresa and San Miguel-Fullon Subdivisions is hereby authorized to construct, install, man and maintain security gates within their respective areas of their association in Barangay Bahay Toro, Quezon City.

SECTION 2. The security gates shall be kept open for free passage from 5:00 A.M. to 11:00 P.M. to be manned by private security guards to be hired by the association.

SECTION 3. The Charters Neighborhood Association shall shoulder the expenses for the construction and installation of the security gates.

SECTION 4. Installation of the steel gates shall be made effective only after consultation with the Office of the City Engineer, Philippine National Police (PNP) and Traffic Management Center.
