AN ORDINANCE APPROVING SUBDIVISION PLAN OF **VILLA AMOR QUATRO (BP BLG. 220)** WITH ONE HUNDRED SIXTY FOUR (164) LOTS CONTAINING AN AREA OF TEN THOUSAND NINE HUNDRED NINETY FOUR (10,994) SQUARE METERS, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED RT-26712 AND 81670 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AND LOCATED AT LOTS NUMBERED 66-A-3 (LRC) PSD-7832 & 66-A-2-E (LRC) PSD-11655 DOVE STREET, BARANGAY BAGONG SILANGAN, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY MR. VILLAMOR C. MACALALAD, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93.




