AN ORDINANCE GIVING CITATION AND CASH AWARDS TO THE OUTSTANDING AND DESERVING PUNONG BARANGAY, BARANGAY KAGAWAD AND SANGGUNIANG KABATAAN OFFICIAL IN EVERY DISTRICT OF QUEZON CITY AS PART OF THE CULMINATION OF THE ANNUAL CELEBRATION OF QUEZON CITY BARANGAY DAY AND CHARGING THE NECESSARY AMOUNT THEREFOR AGAINST THE BUDGET ALLOTED FOR THE BARANGAY DAY CELEBRATION PURSUANT TO SECTION 3 OF ORDINANCE NO. SP-280, S-95.

WHEREAS, Ordinance No. SP-280, S-95 declared June 25, 1995 and every June 25th of every year thereafter as the celebration of Barangay Day in Quezon City;


WHEREAS, the Quezon City Council recognizes the Barangay and Sangguniang Kabataaan officials as competent partners in government service;

WHEREAS, all efforts must be exerted to acknowledge, honor and inspire the Barangay and Sangguniang Kabataan officials for the invaluable support they render in uplifting the condition of their respective community, in particular and of our nation, in general;

WHEREAS, recognizing the exceptional achievement of the barangay leaders will surely redound to the best interest of their constituents as it will encourage these officials to do their task and duty with much vigor, ethusiasm and dedication.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED.



SECTION 1. Citation and cash awards are hereby given to the outstanding and deserving Punong Barangay, Barangay Kagawad and Sangguniang Kabataan official in every District of Quezon City as part of the culminating activity of the annual celebration of Quezon City Barangay Day effective June 25, 2000 and every June 25th of every year thereafter.

SECTION 2. The selection of nominees for the three catergories, namely, OUTSTANDING PUNONG BARANGAY, OUSTANDING BARANGAY KAGAWAD AND OUTSTANDING SANGGUNIANG KABATAAN OFFICIAL at the barangay level shall be chosen by a jury of peers of the particular Barangay Council and Sangguniang Kabataan Council concerned, respectively. The chosen candidate in each category at the barangay level shall vie for Area Level and, likewise, the winner at the Area level shall vie for District Level.

SECTION 3. The judging for the Outstanding Punong Barangay, Oustanding Barangay Kagawad and Outstanding Sangguniang Kabataan official shall be based on the following criteria:

SECTION 4. A Special Committee for this purpose is hereby created to assess and judge the qualifications of nominees/candidates on District Level based on the above cited criteria. This Special Committee shall be composed of the President ng Liga ng mga Barangay, as Chairman; President of the Federation of Sangguniang Kabataan, as Co-Chairman: one (1) representative each from the office of Barangay Operations Center, Community Relations Office and the Office of the Mayor as Members. The committee shall convene before the end of April to deliberate, issue guidelines, adopt measures and thresh out important matters that will be beneficial and for the promotion of the objective of this ordinance. All other rules/regulations and measures not covered by this Ordinance shall be drafted/formulated by the Special Committee.

SECTION 5. The candidates for the three categories shall be judged on the basis of their yearly performance effective April 1, 1999 to April 30, 2000 and every year thereafter.

SECTION 6. The winners on the three categories will each receive a plaque of recognition and a cash prize amounting to Twenty-Five Thousand Pesos (P25,000.00) each, as follows:

OUTSTANDING PUNONG BARANGAY

1 winner/District - 4 x P25,000.00 = P100,000.00

OUTSTANDING BARANGAY KAGAWAD

1 winner/District - $4 \times P25,000.00 = P100,000.00$

OUTSTANDING SANGGUNIANG KABATAAN OFFICIAL

1 winner/District - 4 x P25,000.00 = P100,000.00

SECTION 7. The amount necessary for the implementation of this Ordinance shall be taken from the Two Million Five Hundred Thousand Pesos (P2.5M) budget alloted for the annual celebration of Barangay Day as provided in Section 3 of Ordinance No. SP-280, S-95.

SECTION 8. The offices of the Liga ng mga Barangay, Pederasyon ng Sangguniang Kabataan and Barangay Operations Center are hereby tasked to efficiently disseminate this ordinance the soonest possible time to all the one hundred forty-two (142) Barangays of Quezon City.
