ORDINANCE NO. SET BOD 7

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF HEMADY HEIGHTS, A TWO-STOREY FOUR (4) RESIDENTIAL UNITS BUPLEX WITH ATTIC EIGHT (8) LOTS, CONTAINING AN AGGREGATE AREA OF ONE THOUSAND FIVE HUNDRED EIGHTY-SIX (1,586) SQUARE METERS, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED N-211595 AND N-211596 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF YIN ENTERPRISES AND DEVELOPMENT CORP., AND LOCATED AT LOTS 2-A AND 2-B (LRC) PSD-59988, 64 AND 74-A HEMADY STREET CORNER 12TH STREET, NEW MANILA, BARANGAY MARIANA, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE OWNER, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO SP-36, S-93 AND PD 957.

SECTION 1.
