ORDINANCE NO. SP- 912 ⁹¹² 2000

AN ORDINANCE WITHDRAWING FROM PUBLIC USE AND CONVERTING INTO RESIDENTIAL THE PARCELS OF LAND OWNED BY THE QUEZON CITY GOVERNMENT DESCRIBED UNDER TRANSFER CERTIFICATES OF TITLE NUMBERED 172873, 172924 AND 172925, CONSISTING OF FIFTEEN THOUSAND FIVE HUNDRED NINETY-THREE (15,593) SQUARE METERS SITUATED AT PUROK STO. NIÑO, CHESTNUT STREET, OAK EXTENSION, WEST FAIRVIEW, QUEZON CITY.

Introduced by Councillors WINSTON "Whinie" T. CASTELO, ENRICO S. SERRANO, ERIC Z. MEDINA, MARCIANO P. MEDALLA, MARCEL C. BILLO, CUDOPFREDO T. LIBAN II, ALMARIO E. FRANCISCO and JORGE L. BANAL.

WHEREAS, there are parcels of land covered by Transfer Certificates of Title Numbered 172873, 172924 and 172925 which are open spaces owned by the Quezon City government;

WHEREAS, the said parcels of land are presently occupied for several years by the members and officers of Sitio Sto. Niño, Chestnut West Fairview, Quezon City, Inc., an association duly registered with the Securities and Exchange Commission;

WHEREAS, there is a need to withdraw from its public use and convert the same into residential the said parcels of land before it will be awarded to the residents/members who are petitioning the Quezon City government to allow them to acquire the property thru direct sale or other legal means the lots they are respectively occupying.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. It is hereby withdrawn from public use and converted into residential the parcels of land owned by the Quezon City government described under Transfer Certificates of Title Numbered 172873, 172924 and 172925 consisting of Fifteen Thousand Five Hundred Ninety-Three (15,593) square meters situated at Purok Sto. Niño, Chestnut Street, Oak Extension, West Fairview, Quezon City.

SECTION 2. This Ordinance shall take effect upon its approval.
