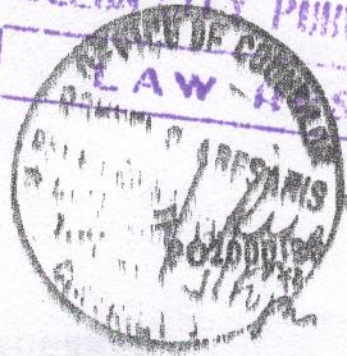

ORDINANCE NO. SP-925, S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF GOOD HAVEN COMPOUND III, 1-STOREY RESIDENTIAL UNITS WITH THIRTY-TWO (32) LOTS, CONTAINING AN AREA OF THREE THOUSAND TWO HUNDRED SIXTY-SEVEN (3,267) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-70284 OF THE REGISTRY OF DEEDS OF QUEZON CITY, OWNED BY EMETERIO A. EUGENIO, LOCATED AT LOT 2-C-1, PSD-33685; MASAYA CORNER SUSANA STREETS, BARANGAY GULOD, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE OWNER, WITH OFFICE ADDRESS AT RM 4 4/F, FILIPINA BLDG., 484 QUIRINO HIGHWAY, BARANGAY TALIPAPA, QUEZON CITY, METRO MANILA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND PD 957.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED :

SECTION 1. The subdivision plan of GOOD HAVEN COMPOUND III, 1-storey residential units with thirty-two (32) lots, containing an area of Three Thousand Two Hundred Sixty Seven (3,267) sq. mts., covered by Transfer Certificate of Title Numbered RT-70284 of the Registry of Deeds of Quezon City, owned by EMETERIO A. EUGENIO, located at Lot 2-C-1, PSD-33685, Masaya corner Susana Street, Barangay Gulod, Novaliches, Quezon City, Metro Manila, as applied for by the owner, with postal address at RM 4 4/F, Filipina Bldg., 484 Quirino Highway, Barangay Talipapa, Quezon City, Metro Manila, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and PD 957, details of which are as follows:
