ORDINANCE NO. 87, S. 8, 1999

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF FAIRVIEW PARK HOMES - VERBENA: 2-STOREY DUPLEX TOWNHOUSES WITH TWELVE (12) UNITS, CONTAINING AN AREA OF NINE HUNDRED SIXTY (960) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED BT-33093 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF GOVERNMENT SERVICE INSURANCE SYSTEM, LOCATED AT LOT 6, BLK. 4 (LRC) PCS-13293 VERBENA ST., FAIRVIEW PARK HOMES, FAIRVIEW PARK SUBDIVISION, BARANGAY FAIRVIEW, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE COLLECTIVE PROJECT MANAGEMENT, INC. WITH OFFICE ADDRESS AT 5/F EYKAL BLDG., 833 PASEY ROAD, MAKATI CITY, METRO MANILA, IS HEREBY APPROVED, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. 87-98, S-91 AND P.D. 937.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

ACTION 1. The Subdivision Plan of FAIRVIEW PARK HOMES - VERBENA: 2-Storey Duplex Townhouses with twelve (12) Units, containing an area of Nine Hundred Sixty (960) square meters, covered by Transfer Certificate of Title Numbered BT-33093 of the Registry of Deeds of Quezon City, registered in the name of Government Service Insurance System, located at Lot 6, Blk 4 (LRC) PCS-13293, Verbena St., Fairview Park Homes, Fairview Park Subdivision, Barangay Fairview, Quezon City, Metro Manila, as applied for by the Collective Project Management, Inc., with office address at 5/F Eykal Bldg., 833 Pasey Road, Makati City, Metro Manila, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. 87-98, S-91 and P.D. 937, details of which are as follows:


