ORDINANCE NO. SP- 939 S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF JUBILEE VILLAS, A 2-STOREY TOWNHOUSE PROJECT WITH THIRTY-FIVE (35) UNITS, CONTAINING AN AREA OF FOUR THOUSAND THREE HUNDRED FORTY-TWO (4,342) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. RT-2966 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF EPOCH PROPERTIES, INC., AND LOCATED AT 90 BANLAT ROAD, BRGY. TANDANG SORA, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE OWNER WITH POSTAL ADDRESS AT 1407 ANGONO CORNER OSMEÑA STREETS, MAKATI CITY, METRO MANILA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93, AND PD 957.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:


SECTION 1. The subdivision plan of JUBILEE VILLAS, a 2-Storey Townhouse Project with thirty-five (35) units, containing an area of Four Thousand Three Hundred Forty-Two (4,342) square meters, covered by Transfer Certificate of Title No. RT-2966 of the Registry of Deeds of Quezon City, registered in the name of EPOCH PROPERTIES, INC., and located at 90 Baulat Road, Brgy. Tandang Sora, Quezon City, Metro Manila, as applied for by the owner with postal address at 1407 Angono corner Osmeña Streets, Makati City, Metro Manila, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and PD 957, details of which are as follows:
