AN ORDINANCE APPROVING THE ANNUAL BUDGET OF THE QUEZON CITY GOVERNMENT FOR CALENDAR YEAR 2001 IN THE TOTAL HUNDRED MILLION AMOUNT OF FOUR BILLION SEVEN (P4,700,000,000.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE CITY GOVERNMENT FOR THE YEAR 2001 AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Annual Budget of the Quezon City government for Calendar Year 2001 in the total amount of Four Billion Seven Hundred Million Pesos (P4.700.000.000.00) covering the various expenditures for the operation of the city government for the year 2001, is hereby approved.

SECTION 2. There is hereby appropriated from the General Fund the sum of Four Billion Seven Hundred Million Pesos (P4,700,000,000,00) or so much thereof as may be necessary, to be made available to cover for the expenditures provided in Section 1 hereof, the sum to be taken from the estimate of revenues certified as available for appropriation by the City Treasurer as contained in the budget documents.

SECTION 3. If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 4. This Ordinance shall take effect on January 1, 2001.
