ORDINANCE NO. SP-⁹⁷⁴~~974~~-2000

AN ORDINANCE GRANTING HEALTHCARE BENEFITS THROUGH THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) TO ALL BARANGAY OFFICIALS SANGGUNIANG KABATAAN OFFICIALS, LUPON TAGAPAMAYAPA MEMBERS AND REGULAR BARANGAY SECURITY AND DEVELOPMENT OFFICERS (BSDOs) OF QUEZON CITY AND APPROPRIATING THE AMOUNT OF SEVEN MILLION PESOS (7,000,000.00) MORE OR LESS, IN THE 2001 ANNUAL BUDGET AND EVERY YEAR THEREAFTER FOR THIS PURPOSE.

WHEREAS, the Barangay Officials, Sangguniang Kabataan Officials, Lupon Tagapamayapa Members and regular Barangay Security and Development Officers (BSDOs) are the forerunners in the delivery of basic and vital services to the citizenry of Quezon City;

WHEREAS, some of them belong to the poor and marginalized sector of our society and, thus, cannot afford the prohibitive cost of medicines and cannot avail of proper medical care, attention and hospitalization when needed;

WHEREAS, the Quezon City government is aware of this need and shall provide as additional health care insurance benefit through the Philippine Health Insurance Corporation (Philhealth), a government owned and controlled corporation;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby granted health care benefits through the Philippine Health Insurance Corporation (PHILHEALTH) to all Barangay Officials, Sangguniang Kabataan Officials, Lupon Tagapangasiwa Members and regular Barangay Security and Development Officers of Quezon City.




