AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED BOUSING PROJECT (BP BLG. 220) WITH TWENTY-FOUR (24) LOTS, COMMUNITY MORTAGE PROGRAM, CONTAINING AN AREA OF ONE THOUSAND ONE HUNDRED FORTY (1,140) SQ. METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE No. RT-49906 OF THE REGISTRY OF DEEDS OF QUEZON CITY, OWNED BY MR. RODOLFO P. LEJANO, JR.
