
(City Council) 13th Special Session



AN ORDINANCE AMENDING ORDINANCE NO. SP-836, S-99, OTHERWISE KNOWN AS THE "AMENDMENT TO ORDINANCE NO. SP-625, S-98, RECTIFYING THE SIXTY-FOUR (64) POSITIONS OF LOCAL TREASURY OPERATIONS OFFICER I (SG-11) TO LOCAL TREASURY OPERATIONS OFFICER II (SG-15) UNDER THE INSPECTION AND EXAMINATION DIVISION, OFFICE OF THE CITY TREASURER, QUEZON CITY, AND DIRECTING THE CITY BUDGET OFFICER TO ALLOCATE THE NECESSARY FUNDS THEREFOR, SUBJECT TO THE AVAILABILITY OF FUNDS", BY PROVIDING THE FIFTH (5th) SALARY STEP INCREASE WITHIN THE SAME SALARY GRADE LEVEL TO THE INCUMBENT LOCAL TREASURY OPERATIONS OFFICER II, LOCAL REVENUE COLLECTIONS OFFICER II AND HUMAN RESOURCE MANAGEMENT OFFICER II UNDER THE INSPECTION AND EXAMINATION DIVISION, REAL ESTATE DIVISION, TAXES AND FEES DIVISION AND ADMINISTRATIVE DIVISION, OFFICE OF THE CITY TREASURER".

Introduced by Councilor JESUS C. SUNTAY.

WHEREAS, the Sangguniang Panlungsod of Quezon City has enacted Ordinance No. SP-836, Series of 1999, upgrading the positions of the Seventeen (17) Local Treasury Operations Officer II (SG-15) due to clamor of existing disparities between the salaries of the Local Treasury Operations Officer II and the incumbent Local Treasury Operations II and Local Collections Officer II, making the Office of the City Treasurer a flat organization contrary to the standard hierarchical structure of one department;

WHEREAS, one of the effects of the passage of the said ordinance is the exclusion of two (2) Local Treasury Operations Officer II from the Taxes & Fees Division, one (1) Local Revenue Collections Officer II from the Real Estate Division, one (1) Local Treasury Operations Officer II from the Real Estate Division and one (1) Human Resource Management Officer II from the Administrative Division of the Quezon City Treasurer's Office, which created demoralization to the incumbent of the following Items Numbered 119-1,128-1, 155-1, 162 and 22;

WHEREAS, it is incumbent upon the City Government to prohibit those who have already benefited by the passage of Ordinance No. SP-625, Series of 1998 and Ordinance No. SP-836, Series of 1999, related to the upgrading of salaries by incumbent employees be barred from taking another action from the same body in seeking for another upgrading of the same positions, thereby creating another imbalance in the organizational structure of the City Treasurer's Office;


WHEREAS, the beneficiaries of Ordinance No. SP-625, Series of 1998 and Ordinance No. SP-836, Series of 1999 be prohibited to be benefited of any other subsequent ordinance which seeks to disturb the equitable implementation of Republic Act No. 6758, otherwise known as the "Salary Standardization Law", by the defunct Joint Commission on Local Government Personnel Administration (JCLGPA);

WHEREAS, those personnel who have been benefited from the abovementioned Ordinances enacted by Sangguniang Panlungsod of Quezon City, whose positions have been upgraded be barred from again seeking the assistance of the same body regarding the second upgrading of their positions;

WHEREAS, it is incumbent upon the City government of Quezon City to conect this situation such as to elicit the highest level of morale and confidence among the employees in the Office of the City Treasurer;

NOW, THEREFORE.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Ordinance No. SP-836, S-99, is hereby amended to read as follows:

"Section 1 (a). The sixty-four (64) positions of Local Treasury Operations Officer I (SG-11) under the Inspection and Examination Division, Office of the City Treasurer, Quezon City, are hereby rectified to Local Treasury Operations Officer II (SG-15), 59-1 to 59-24, 66-1 to 66-32, 138, 143-1 to 143-6 and one (1) vacant positions.

- (b). The seventeen positions of the incumbent Local Treasury Operations Officer II (SG-15) under the Inspection and Examination Division, Real Estate Division, and Taxes and Fees Division, and the four (4) Local Revenue Collection Officer II (SG-15), Office of the City Treasurer, Quezon City, are hereby rectified and reclassified by providing a fifth (5th) salary step increase within the same salary grade level, from Php 11,515.00 per month to Php 12,710 per month, the listing of the item numbers, division name, and the incumbent, with item number 58-1 to 58-3, 65-1 to 65-4, 119-2 to 119-5, 124-1, 132, 137, 142, 148, 167, 36-1, 40-1,45-1 and 50.
- (c). The two (2) positions of incumbent Local Treasury Operations Officer II (SG-15) under the Taxes and Fees Division, One (1) Local Revenue Collection Officer II (SG-15), One (1) Local Treasury Operations Officer II both under the Real Estate Division and One (1) Human Resource Management Officer II under the Administrative Division, Office of the City Treasurer, Quezon City, are hereby rectified and reclassified by providing a fifth (5th) salary step increase within the same salary grade level, from Php 11,515.00 per month to Php 12,710 per month, the listing of the item numbers, division name, and the incumbent, with item number 162, 128-1, 155-1, 119-1, and 22.

(d). The positions mentioned in letter (c) above be given a salary differential effective November, 1999, same as that of those in letter (b) above.

Section 2. The City Personnel Officer is hereby directed to incorporate the positions rectified in Section 1 (a) and Section 1 (b) hereof in the official personnel schedule of the Quezon City government.

Section 3. (a). The City Finance Committee and the City Budget Officer are hereby directed to allocate the amount of Five Million Eight Hundred Ninety-Six Thousand Sixty Four Pesos (Php 5,896,064.00) for the payment of the salary differential to the incumbents of the position rectified under Section 1 (a) hereof effective fiscal year 1995, subject to availability of funds. The schedule of which is hereunder enumerated:

(b). The City Finance Committee and the City Budget Officer are hereby directed to allocate the amount of One Hundred Ninety-Eight Thousand Two Hundred-Fifty Pesos and Fifty Centavos (Php 198,250.50) for the payment of the salary differential to the incumbents of the position rectified under Section 1(b) hereof effective July 1999, subject to the availability of funds. The schedule of which is hereunder enumerated;

(c). The City Finance Committee and the City Budget Officer are hereby directed to allocate the amount of Fifty Four Thousand and Eighty Pesos (PhP 54,080.00) for the payment of the salary differential to the incumbent of the positions rectified under Section 1(c) hereo effective July 1999, subject to the availability of funds. The schedule of which is hereunder enumerated:
