ORDINANCE NO. SP-1005, ~~S~~-2001

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO SANGGUNIANG KABATAAN MEMBERS INCLUDING SK SECRETARIES AND SK TREASURERS IN QUEZON CITY AT THE RATE OF FIVE HUNDRED PESOS (P500.00) EACH PER MONTH FROM JANUARY 1, 2001 TO JUNE 30, 2001 ONLY AND THE SUCCEEDING YEAR THEREAFTER WHICH SHALL BE INCLUDED IN THE 2002 ANNUAL BUDGET AND FOR THE SUCCEEDING YEARS THEREAFTER.

WHEREAS, under the provision of the Local Government Code of 1991, unlike the sangguniang kabataan chairman "who shall automatically serve as an ex-officio member of the sangguniang barangay upon his assumption of office" and "as such, he shall exercise the same power, discharge the same duties and function, and enjoy the same privileges as the regular sangguniang barangay members", the sangguniang kabataan members are not entitled to the said power and privileges;

WHEREAS, while modest financial assistance to those sangguniang kabataan members in Quezon City may not adequately fill their needs, it can, however, spell out the City's abiding concern for them and would serve as an inspiring incentive to these sangguniang kabataan officials who are actually our young leaders in the making;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby granted financial assistance to Sangguniang Kabataan Members including SK Secretaries and SK Treasurers in Quezon City, at the rate of Five Hundred Pesos (P500.00) each per month, effective January 1, 2001 to June 30, 2001.


