AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF AN ECONOMIC HOUSING PROJECT (BP BLG. 220) WITH SEVEN (7) LOTS CONTAINING AN AREA OF FOUR HUNDRED (400) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 313215 OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 4, BLOCK 13 (LRC) PCS-1387, DIEGO SILANG STREET, T.S. CRUZ SUBDIVISION, BARANGAY SAN AGUSTIN, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY CONRADO P. DIZON, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. 
