

## ORDINANCE NO. SP-1014 S-2001

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF AN ECONOMIC HOUSING PROJECT (BP BLG. 220) WITH SIX (6) LOTS, CONTAINING AN AREA OF TWO HUNDRED FIFTY-ONE (251) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-78085 OF THE REGISTRY OF DEEDS OF QUEZON CITY, OWNED BY ELPIDIO PALENCIA, AND LOCATED AT LOT 7, BLOCK 1 (LRC) PSD-35216, IMELDA STREET. CAPRI, BARANGAY NAGKAISANG NAYON, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE OWNER SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1.
