AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF AN ECONOMIC HOUSING PROJECT (BP BLG. 220) WITH SIX (6) LOTS, CONTAINING AN AGGREGATE AREA OF TWO HUNDRED EIGHTY-NINE (289) SQUARE METERS COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED N-161793 AND N-161794 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AND LOCATED AT LOTS 2 AND 3, BLOCK 1, PSD-13-013606 LITEX ROAD, VILLA GRACIA HOMES I, BARANGAY PAYATAS, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY ROSMIL REALTY AND DEVELOPMENT CORPORATION, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO.
