AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED HOUSING PROJECT (BP BLG. 220), COMMUNITY MORTGAGE PROGRAM, WITH ONE HUNDRED TEN (110) LOTS, CONTAINING AN AREA OF FOUR THOUSAND FIVE HUNDRED FIVE (4,505) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-221000 OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 811-B-3-B-4-E REPUBLIC AVENUE, BARANGAY HOLY SPIRIT, QUEZON CITY, METRO MANILA, OWNED AND APPLIED FOR BY THE IDEAL HOMEOWNERS ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a Socialized Housing Project (BP Blg. 220) Community Mortgage Program, with one hundred ten (110) lots, containing an area of four thousand five hundred five (4,505) square meters, covered by Transfer Certificate of Title Numbered N-221000 of the Registry of Deeds of Quezon City, located at Lot 811-B-3-B-4-E Republic Avenue, Barangay Holy Spirit, Quezon City Metro Manila, owned and applied for by the IDEAL HOMEOWNERS ASSOCIATION, INC., is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:




