ORDINANCE NO. SP- 10392 , S-2001

AN ORDINANCE CREATING ONE HUNDRED FIFTY-FIVE (155) POSITIONS UNDER THE QUEZON CITY HEALTH DEPARTMENT CORRESPONDING SALARY AND APPROPRIATIONS FOR RATES PERSONNEL COMPRISING THE IMPLEMENTATION OF THE AMENDED MEMORANDUM OF AGREEMENT ENTERED INTO BY THE DEPARTMENT OF HEALTH, THE OUEZON CITY GOVERNMENT AND THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT IDENTIFIED AS DOC. NO. 286, PAGE NO. 59, BOOK 2, SERIES OF 1999 OF NOTARY PUBLIC ATTY. AGRIPINO G. GALVEZ.

Introduced by Councilors RAMON G. MATHAY, WILMA AMORANTO-SARINO, VINCENT P. CRISOLOGO, ROMMEL R. ABESAMIS, MA. FRESCA M. BIGLANG-AWA, GODOFREDO T. LIBAN II, MARCIANO P. MEDALLA, ERIC Z. MEDINA and JORGE L. BANAL.

WHEREAS, a Memorandum of Agreement (MOA) was entered into in the City of Manila by the Department of Health, Quezon City government and the Department of Interior and Local Government respecting the implementation of the Urban Health Nutrition Project (UHNP) within the LGU's territorial jurisdiction;

WHEREAS, the goals of the UHNP overall plan has already been achieved and under paragraph 3:B, 5.1, (b) of the MOA, Quezon City obligated itself to-

"Appoint all UHNP-supported contractual personnel within its territorial jurisdiction to be placed under the supervision and control of the LGU officials concerned. Upon completion of the life of the project, the services of the contractual personnel shall be terminated. However, the corresponding positions of such personnel shall be absorbed and form part of the LGU workforce. The position, therefore, becomes available to qualified applicants including the personnel previously employed for the same position."

WHEREAS, Quezon City has appropriated 80% of the required funds for the salaries/compensation of all personnel hired on contractual basis under the MOA;

WHEREAS, there is now an obligation on the part of the Quezon City government to fully implement the above-mentioned provision of the MOA by creating permanent positions for the hired contractual personnel and provide additional funds therefor,

## NOW, THERFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There are hereby created One Hundred Fifty Five (155) positions under the Quezon City Health Department, broken down as follows:

SECTION 2. The Amount of Twenty Seven Million Three Hundred Thirty Thousand Eight Hundred Thirty Four Pesos (P27, 330,834.72) or so much thereof as maybe necessary is hereby appropriated to cover additional funds for the salaries, insurance and other increment of compensation required for the said positions mentioned in Section 1 hereof,

SECTION 3. The present contractual employees shall be given priority right to be hired as permanent personnel in the newly created positions; Provided, however, they possess the qualification required for appointment to the said positions.

SECTION 4. This Ordinance shall take effect upon its approval.
