AN ORDINANCE AMENDING SECTIONS 1 AND 5 OF ORDINANCE NO. SP-1038, S-2001, GRANTING A SALARY INCREMENT TO ALL EMPLOYEES HOLDING PLANTILLA POSITIONS UP TO THE THIRD STEP OF THEIR RESPECTIVE SALARY GRADE LEVELS.

WHEREAS, Sec. 352 (g) of the Local Government Code of 1991 provides that *"the creation of new positions and salary increases or adjustments shall in no case be made retroactive;"*

WHEREAS, there was an inadvertence in Ordinance No. SP-1038, S-2001, whereby the same has provided for its retroactive effect thus, contravening the above quoted provision of law;

WHEREAS, Ordinance No. SP-1038, S-2001 needs an amendment by rectification.

NOW, THEREFORE,

BE IT ORDAINED BY CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The second paragraph of Section 1 of Ordinance No. SP-1038, S-2001, is hereby amended, to read as follows:

"Those employees whose salaries are beyond the third step of their respective salary grades are not covered by this ordinance."


