ORDINANCE NO. SP- 1059, S-2001

AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS IN QUEZON CITY TO INCREASE THEIR THEATER ADMISSION FEE BY ONE PESO (P1.00) COVERING THE PERIOD FROM AUGUST 1-31, 2001, TO SUPPORT THE PROGRAMS AND ACTIVITIES OF THE BOY SCOUTS OF THE PHILIPPINES, QUEZON CITY CHAPTER.

WHEREAS, the Boy Scouts of the Philippines, Quezon City Chapter (BSP-QC) has been continually in the forefront of training and molding future leaders of the land;

WHEREAS, the BSP-QC has, as of date, been operating on a minimal funding due to budgetary constraint caused by the current economic situation;

WHEREAS, requiring cinema owners and operators to increase their theater admission fee by One-Peso (P1.00) for a certain period of time to support programs of this nature has been exercised in the past by this Council.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED.

SECTION 1. All Cinema owners and operators within Quezon City are hereby required to increase their theater admission fee by One Peso (P1.00) covering the period from August 1-31, 2001, to be remitted to the Boy Scouts of the Philippines, Quezon City Chapter (BSP-QC) or its duly authorized agents/representatives.






