

ORDINANCE NO. SP () 7, 1-2001

AN ORDINANCE ESTABLISHING A "BANTAYOG NG MGA PUNONG BARANGAY NG LUNGSOD QUEZON" TO SERVE AS A LASTING MEMORIAL TO THE BARANGAY CHAIRMEN OF QUEZON CITY WHO DIED DURING THEIR TERM OF OFFICE.

WHEREAS, by the nature of their positions, Barangay Chairmen perform the extraordinary tasks that transcend the functions of the three branches of government, as the local Chief Executive, as Legislator in the Sangguniang Barangay, and as Judge/Conciliator in their capacity as Chairmen of the Lupong Tagapamayapa;

WHEREAS, as public servant, the Barangay Chairmen are subject to various kinds of risks and dangers in the performance of their 24-hour job, hence, they deserve the eternal gratitude of our people by way of a memorial that would serve as reminder of their heroic service and exemplary deeds that led to the development of Quezon City;

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby created a memorial to be named "Bantayog ng mga Punong Barangay ng Lungsod Quezon" to serve as a lasting tribute to the Barangay Chairmen of Quezon City who died during their incumbency.

SECTION 2. Coverage. - All Barangay Chairmen, who were voted into office in the barangay elections and who, by any reason, died during their term of office are eligible to be accorded the posthumous recognition from the City government.

SECTION 3. The Parks Development and Administration Department, the Barangay Operations Center, the Engineering Department and the Liga ng mga Barangay shall jointly formulate the necessary guidelines for the effective implementation of this Ordinance.
