AN ORDINANCE REGULATING THE USE OF STREETS SPECIFICALLY CHRONICLE STREET CORNER EXAMINER STREET, EVENING NEWS STREET CORNER EXAMINER STREET, BULLETIN STREET CORNER EXAMINER STREET, BULLETIN STREET CORNER WEST AVENUE, CHRONICLE STREET CORNER LIWAYWAY STREET, MABUHAY STREET CORNER WEST AVENUE, TIMES STREET CORNER EPIFANIO DELOS SANTOS AVENUE (EDSA), TOMAS BENTIEZ STREET CORNER EDSA, TOMAS BENTIEZ STREET CORNER EXAMINER STREET, AND EXAMINER STREET CORNER TIMES STREET (NORTH SIDE) BY CLOSING THE ABOVE MENTIONED STREETS FROM 10:00 P.M. TO 4:00 A.M. DAILY.

WHEREAS, a resolution duly signed and approved by the concerned officials of Barangay West Triangle was forwarded to the City Council urging the City Council to authorize the Barangay Council for the installation of street gates in the entrance and exit of the following streets: Chronicle St. corner Examiner St., Evening News St. corner Examiner St., Bulletin St. corner Examiner St., Bulletin St. corner West Avenue, Chronic St. corner Liwayway St., Mabuhay Street corner West Avenue, Times Street corner Epifanio Delos Santos (EDSA), Tomas Benitez Street corner EDSA, and Examiner Street corner Times Street (North Side) for security purposes.

WHEREAS, it is imperative to authorize the installation of street gates and regulate the use by the public of the abovementioned street: in the affluent community o prevent any incidence of snatching, hold up, carnapping or robbery by akyat-bahay, bukas-kotse gang, salisi, budol-budol and dugo-dugo gang, perverts and maniacs wandering around the vicinity of the barangay during the wee hours of the evening;

WHEREAS, the City Council as many ated by the Local Government Code of 1991 has the power to regulate the use of streets, alleys and 'horoughfares.

NOW, THEREFORE,

ASSEMBLED.

SECTION 1. To regulate the use of streets specifically Chronicle Street corner Examiner Street, Evening News Street corner Examiner Street, Bulletin Street corner Examiner Street, Bulletin Street corner West Avenue, Chronicle Street corner Liwayway Street, Mabuhay Street

corner West Avenue, Times Street corner Epifanio Delos Santos Avenue (EDSA), Tomas Benitez Street corner EDSA, Tomas Benitez Street corner Examiner Street and Examiner Street corner Times Street (North Side) and have them closed for public use from 10:00 p.m. to 4:00 a.m. daily.

SECTION 2. Provided that the following streets, Tomas benitez Street corner Examiner Street. Times Street corner West 4th Street and Sgt. Esguerra Extension corner Quezon Avenue shall remain open for twenty-four (24) hours.

SECTION 3. Closed Streets can be ordered opened by the City Mayor, Chief of Police or the City Council, when the need arises, without the need of public hearing or another ordinance.

SECTION 4. This Ordinance shall take effect immediately upon its approval.
