ORDINANCE NO. SP- 1096, 2002

AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS TO INCREASE TICKET PRICES BY ONE PESO (P1.00) DURING THE ENTIRE MONTH OF MARCH 2002 FOR THE PURPOSE OF SUPPORTING THE SCOUTING PROGRAM OF THE QUEZON CITY GIRL SCOUT.

WHEREAS, the said Council has been involved not only in the enhancement of the physical and moral aspects of our female youths but also assists other organizations such as Alay Lakad Foundation, DSWD, Tulong Bata Project Foundation, among others;

WHEREAS, Girl Scout of the Philippines has been known locally and internationally of its bold involvement in drug prevention, social and civic works, tree planting, clean and green, Adopt a Purok Program, and other religious activities;

WHEREAS, the Girl Scout Movement which serves as training ground for young women needs our support for its projects/programs and activities through minimal contributions of the general public.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. All cinema owners and operators in Quezon City are hereby required to increase theater admission prices by one peso (P1.00) for the entire month of March, 2002.



SECTION 3. This Ordinance shall take effect immediately upon its approval.


