AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS IN QUEZON CITY TO INCREASE THE PRICES OF THEIR ADMISSION TICKETS BY ONE PESO (P1.00) COVERING THE PERIOD FROM APRIL 1 TO 30, 2002, TO SUPPORT THE PROGRAMS AND ACTIVITIES OF THE BOY SCOUTS OF THE PHILIPPINES, QUEZON CITY CHAPTER.

WHEREAS, the Boy Scout of the Philippines, Quezon City Chapter, has organized various programs and projects to strengthen the Scouting Movement in the Philippines;

WHEREAS, the Boy Scout of the Philippines, Quezon City Chapter, is tentatively scheduled to attend International Conference on Scouting to establish closer relations with their foreign counterparts.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. All cinema owners and operators are hereby required to increase their theater admission fee by One Peso (P1.00) covering the period from April 1 to 30, 2002.

SECTION 2. All proceeds of this fund raising shall be used solely to finance the programs and activities of the Boy Scout of the Philippines, Quezon City Chapter, and a corresponding financial report shall be submitted to the City Council for its information.






