
AN ORDINANCE SEPARATING THE SERGIO OSMEÑA SR. HIGH SCHOOL CAPOAS ANNEX IN BARANGAY MASAMBONG, DISTRICT I, QUEZON CITY, FROM ITS MOTHER SCHOOL, SERGIO OSMEÑA SR. HIGH SCHOOL AND RENAMING IT TO MASAMBONG HIGH SCHOOL.


WHEREAS, pursuant to DECS Order No. 84, S-1996, all public Secondary Annexes shall be given the authority to be separated from their mother institution and that an annex of a public high school which is presently offering a complete Secondary Education Program or one which shall offer fourth year level by next year shall be established as a new high school effective S.Y. 1997-1998 and also all existing annexes or those which shall be established in the future shall be considered as a new high school during the school year when they shall begin to offer fourth year level;

WHEREAS, Sergio Osmeña High School-Capoas Annex has now existed for sixteen (16) years since its opening in 1985 by the Quezon City Government through the initiative of the community of Barangay Masambong assisted by the Federation of Filipino Chinese Chamber of Commerce. It has produced high school graduates for the past two (2) years and each student excelled in both academic, cultural and physical competition in the district, division, regional and as well as in national levels;

WHEREAS, the Sergio Osmeña Sr. High School-Capoas Annex has a school site with an area of seven thousand six hundred fifty square meters (7,650 sq. m) allocated by the local government of Quezon City. There are 2-storey buildings, a four-classroom extension building, a big canteen and three makeshift classrooms. The first 2-storey building was constructed in 1987 and the second 2-storey building was constructed in 1997. The four classroom extension building was constructed in 1992 while the school canteen and the three classroom makeshift was in 1999 together with the vocational building.







WHEREAS, although Sergio Osmeña Sr. High School-Capoas Annex and its mother school both belong to the same district and barangay with only around two kilometer distance from each other however, it was stated in the DECS Order No., 5, S-1989, under Section 3 that "requirements for the exercise of the Delegated Authority pursuant to Section 7 of R.A. 6655: (2) no new public secondary schools may be established within a two-kilometer radius from an existing secondary school, public or private. However, if private and public schools cannot provide accommodation to students seeking admission, this limitation may be waived where existing private and public schools cannot provide accommodation to students seeking admission."

WHEREAS, Sergio Osmeña Sr. High School can no longer accommodate more than four thousand students and students seeking for enrollment is far reaching five thousand students yearly and there is no private school in the area;

WHEREAS, there is no other high school within five kilometers from Sergio Osmeña Sr. High School (Main) to accommodate the graduates of elementary feeders such as Masambong Elementary School, San Francisco Elementary School, Damayan Elementary School, Paltok Elementary School and other private elementary schools;

WHEREAS, Sergio Osmeña Sr. High School-Capoas Annex has a population of more than one thousand students with thirty two (32) regular/permanent teachers with one Head Teacher Officer In-Charge, holding a doctoral degree, and six non-teaching personnel working and taking care of the operation and management of the administration of the school affairs has a need to make this annex, an independent school, separated from its mother institution;


WHEREAS, Sergio Osmeña Sr. High School-Capoas Annex is the oldest annex school in the whole division of Quezon City and yet has not been granted independence;

WHEREAS, all the teaching force, administrator, personnel, parents, students and the whole community of Barangay Masambong and nearby barangays such as Barangay Del Monte, Damayan, Paltok and Kaingin firmly believe that it is high time for the school to be granted its independence.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Sergio Osmeña Sr. High School-Capoas Annex in Barangay Masambong, District I, Quezon City, is hereby separated and totally independent from its mother school, Sergio Osmeña Sr. High School (Main) with all the attributes of a full public secondary high school and to be renamed as Masambong High School.




SECTION 2. The property where the school is located shall be for the exclusive use of the school.

SECTION 3. This Ordinance shall take effect immediately upon its approval.




