AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED RESIDENTIAL HOUSING PROJECT (BF BLG. 220) WITH TWENTY (20) LOTS; COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF SEVEN HUNDRED THIRTY EIGHT SQUARE METERS (738 SQ.M.) COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT.98548 (130848) OF THE REGISTRY OF DEEDS OF OUEZON CITY, LOCATED AT LOT 5, BLOCK 31, (LRC) PSD-9707, BOUGAINVILLA STREET, MALIGAYA PARK, BARANGAY PASONG PUTIK PROPER, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY KAMAMA HOMEOWNERS ASSOCIATION, INC.
