## ORDINANCE NO SP. 1 1.38, S-2002

AN ORDINANCE GRANTING SERVICE REWARD/MERIT IN THE AMOUNT OF TWO THOUSAND PESOS (PHP 2,000.00) TO EACH CONTRACTUAL PERSONNEL OF THE CITY GOVERNMENT COVERED BY CONSULTANCY MANAGEMENT CONTRACT AND CONTRACT OF SERVICE.

WHEREAS, Section 458 (a) (1) (viii) of the Local Government Code of 1991 provides that the Sangguniang Panlungsod shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the city government;

WHEREAS, the City Mayor has issued a certification for the immediate passage of a measure to authorize the payment of service reward/merit to all city personnel covered by consultancy management contracts and contracts of service in recognition of their magnanimous efforts and contributions shown during the recovery process being undertaken by the city government and for rendering an upkeep in the administrative support services/medical service/field operations, etc.

WHEREAS, the city government, realizing the immeasurable performance displayed by its personnel, has expressed its willingness to grant benefits in the form of service reward/merit the amount of which shall be taken from any mailable funds of the Office of the City Mayor,

WHEREAS, this service merit shall be given to all the covered employees usually starting CY 2002 and thereafter, subject to the availability of funds of the City.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Short Title. - This ordinance shall be known as "THE SERVICE MERIT ORDINANCE."

SECTION 2 All city personnel covered by consultancy management contract and contract of service who have rendered at least four (4) months of continuous service for the period from July to December 2001 and are still in the active service as of January 31, 2002 shall be granted a service reward/merit amounting to Two Thousand Pesos (Php 2,000.00) each.

SECTION 3. The funds necessary for the payment of the service reward/merit of the covered personnel shall be taken from any available funds of the Office of the City Mayor.

SECTION 4. The City mayor shall issue the necessary guidelines to effect the distribution of the service reward/merit.

SECTION 5. This ordinance shall take effect immediately upon approval.
